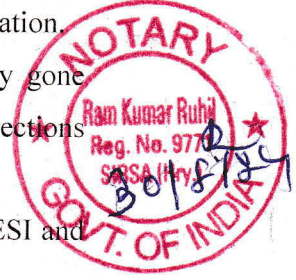



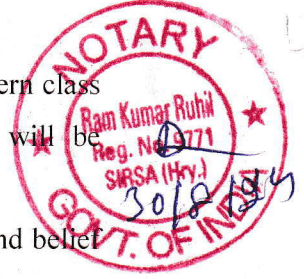
5. That school is not paying any charges towards using name, motto logo or any other on-academic activities to any other institution, organization or body.
